Akshara Type Studio End-User License Agreement (EULA) for “Free Font Software/Free Fonts”

Version: 1.1 , August 2023.

Akshara Type Studio (ATS) fonts are 100% free for personal and commercial use, however, they’re not open-source. Currently we have offered only “Closed Source” fonts. Closed Source fonts are proprietary freeware designed, produced and owned by the Akshara Type Studio (ATS).

Before accessing, downloading, installing, storing, copying, sharing or using any of the fonts from Akshara Type Studio Free Font Software/Free Fonts, you must agree to the terms specified in each licence or in the below agreement. If you do not accept the terms, please do not download or install the Free Software/Free Fonts.

Definitions

This is an Akshara Type Studio Free Font End User Licence Agreement (“FS/FF EULA”) between you as an end user (“Licensee”) and Akshara Type Studio (“Licensor”).

Font Software/Free Fonts refers to the set of computer files or programs released by the Akshara Type Studio under this licence that instructs your computer to display and/or print each letter, characters, typographic designs, ornament and so forth. Derivative Work refers to the pictorial representation of the font created by the Font Software, including typographic characters such as letters, numerals, ornaments, symbols, or punctuation and special characters.
